

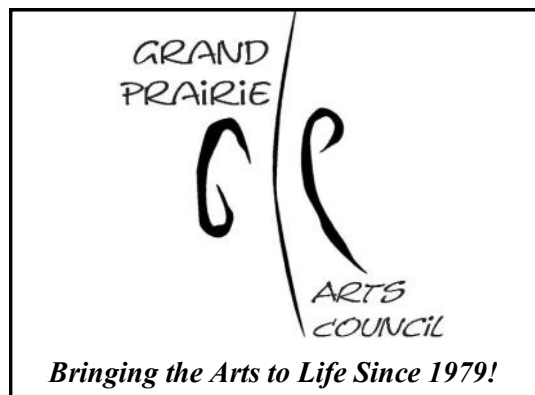

### **Eligibility**

Open to all artists age 18 and over. Entry must be an original work of art, created by the artist entering the piece. It cannot be a copy of a published work of art. Artwork must not have been previously exhibited in a GPAC Show.

### **Categories**

***All media will be considered.***

Including, but not limited to oil, acrylic, watercolor, pastel, mixed media, 3-dimensional, photography, drawing-all media, computer graphics, glass, etc.

*Categories will be determined based on entries received. Your work will be placed in an appropriate category.*

### **Entries and Fees**

**\$35** - Each artist may submit up to three (3) entries for a non-refundable fee of \$35 for entry of 1-3 pieces.

**Each entry and artist may only receive one award in the show.**

Juror information will be included with notice of acceptance.

### **Selection**

***Each artist may submit up to 3 entries for \$35.***

Entries are chosen from images submitted with completed entry forms & paid entry fee. Work different from the accepted images will be disqualified. *GPAC reserves the right to refuse any work submitted.*

### **Entry Image Requirements**

***Entries images may be made by:***

4 x 6 photos or jpeg files on CD mailed to GPAC, or jpeg files emailed to GPAC (300 dpi). Images should show ONLY the work of art (no frame, easel, background, etc.). If sending photos, clearly mark the top of the image on the back of the photo. Please be sure all entries are securely labeled with the artist's name and the title of the piece.

### **Artwork Requirements**

Hanging pieces must be suitably framed, or on stretched canvas. Hanging pieces must be ready to hang with framer's wire attached to the back of the piece using D-ring hangers or the equivalent. Saw-tooth hangers are not permitted. ***If 3-D works exceed 50 lbs., or 48" in height, artist installation is required.***

### **Legal Issues**

Artists are responsible for ensuring that there are no copyright issues, or other legal issues, attached to images used or subjects of their artwork; including images of famous people.

### **Sales**

**All sales will be handled by GPAC. A 15% commission will be assessed. Work not for sale should be clearly marked NFS. All sold pieces must remain hanging until the exhibition closes. This policy will be enforced.**

### **Liability and Insurance**

Although GPAC will exercise great care in handling works submitted to this exhibition; neither the GPAC nor the City of Grand Prairie will be responsible for loss or damages to any work. Artists are responsible for loss or damage to any work. Artists are responsible for insuring their artwork.

### **Return of Work**

***All work must be picked up on October 21: 10:00am - noon.*** (Unless other arrangements have been made with GPAC). A storage fee of \$5.00 per day, will be charged for work not picked up on time, without prior arrangements.
